- ✓ CRESTWOOD gifts should be returned unwrapped in a gift bag with the original tag attached to the bag.
- ✓ SHARE Children's Gifts should be unwrapped but with wrapping paper or gift bag included and original tag included.
- ✓ SHARE Family Gifts should be wrapped and have the original label and inventory of item(s) attached (blank inventory list provided). Family gift cards can be placed in an envelope with the family number on the outside of the envelope.
